## <u>Frenchtown News, Updates, and Topics of Discussion:</u>

Michele Liebtag and Kathy Bernhardt from the Frenchtown Council attended the meeting to review the outline for what will eventually be the draft for the Special Events Ordinance (previously referred to as the Draft Noise Ordinance)

<u>In brief:</u>

- Ideas for the framework came from 3 different nearing town's ordinances
- Permits would need to be submitted to the borough for any outdoor event (with emphasis on amplified types of events)
- You can submit a full calendar of events all at once for review by requesting it to be added to the agenda at the monthly Common Council meeting - categorized under "New Business"
- There would be a \$20 fee for each event 12 events (max) per business/per year

This system will help to keep all parties being in the know, from residential areas this
may affect, the first responders who need to be aware of larger gatherings for safety,
and the town council will be made aware of what's going on in Frenchtown

**Scott Sheldon** - The Frenchtown Bookshop hosts a number of different types of events throughout the year to build community. They have poetry readings, book signings, concerts and more. With that said, he requested more clarification in the draft regarding the specific types of events that would need a permit as he felt the current verbiage includes too wide a range of things.

**Barbara Daniello** - expressed concerns with this draft ordinance being outlined by town's much larger than Frenchtown such as Hillborough, and suggested that we take a look at ordinances of similar towns to ours like Milford or Lambertville.

# Reminder about the NJEDA Small Business Grant Programs present by Kathy Guzman at our last meeting.

- <u>Small Business Lease Grant</u> for new businesses, with a 5+ year lease, ground floor, within 12 months of opening, to received 20% of annual lease for first two years
- <u>Small Business Improvement Grant</u> open to non-profits, up to 2 year look-back, 50% reimbursement (up to 50K) for cost associated with interior/exterior improvements, and/or purchasing/installing new furniture, fixtures, and/or equipment
- <u>Small Business E-Commerce Support Program</u> for restaurant, retail and personal care industries, provides free website or improvements to existing website, and marketing consulting
- New Jersey Capital Access Fund offers flexible, affordable loans at max 12% interest rate without collateral, helps avoid predatory lenders with inflated interest rates
